### What are cookies?

A cookie is a file that is downloaded to devices when accessing certain websites, platforms or applications, to store and retrieve information while the user accesses its content.

Cookies can be used for a wide variety of purposes, such as recognizing the user, obtaining information about the user's browsing habits, or customizing the way in which the content is shown to the user.

### Which cookies can be activated on this website?
